9. Colours and Coat-of-Arms

The colours of the Association shall be green and red, and the coat-of-arms that of Bishopshalt School.

10. **Sections**

The formation of a Section must be sanctioned by the Executive Committee.

Sections shall draw up rules for the efficient control of their Section, such rules to be supplementary to those of the Association.

11. Subscription

All subscription rates for membership shall be decided at the Annual General Meeting. Payment of a Life Subscription shall entitle an old pupil or Associate Member to Life Membership of the Association. Annual Membership subscriptions are due on 31st December in each year.

12. <u>Life Membership Subscriptions</u>

All monies received in the form of subscriptions for Life Membership shall be credited to a Life Members' Reserve Account. Each Life Membership Subscription shall be transferred from this Account to the Annual Income and Expenditure Account in equal instalments over a period of twenty years (ie 5% per annum).

13. **Operation**

The decision of the Executive Committee shall be final in all matters not covered by these rules.

Every member shall be furnished with a copy of these Rules.



OLD UXONIANS' ASSOCIATION

Rules of the Association

June 2003

1. Title

The Association shall be known as the OLD UXONIANS' ASSOCIATION.

The aims of the Association are to maintain contacts between old pupils of Bishopshalt School and to carry on activities to benefit the School.

Officers

The Officers of the Association shall be:

- Chairman
- Vice Chairman
- Hon. Secretary
- Hon Treasurer

3. **Executive Committee**

The Association shall be governed by a Committee to be called the Executive Committee consisting of the Officers and four other members. Five persons shall form a quorum.

In addition, a representative of the School staff, to be nominated by the Headteacher, shall serve as a liaison member.

The Committee shall have the power to fill any vacancy which may occur during its term of office.

4. <u>Election of Officers</u>

The President, Vice- Presidents, Officers and Executive committee shall be elected at the Annual General Meeting, to hold office until the next Annual General Meeting.

5. **Year**

The Association financial year shall end on 31st March.

6. **General Meetings**

The Annual General Meeting shall be held not later than 15th June and within a period of fifteen months from the last General Meeting. At this meeting, the Committee shall present Reports and Balance Sheets.

Special General Meetings may be convened by direction of the Executive Committee or on an application signed by not less than fifteen members of the Association to the Hon. Secretary stating the reason for such a Meeting. Fourteen days notice shall be given of a General Meeting.

7. <u>Alteration of the Rules of the Association</u>

Propositions affecting the Rules of the Association must be agreed by two-thirds of the members present either at a Special General Meeting convened for the purpose or at the Annual General Meeting.

Details of such propositions will be incorporated into the Agenda of the meeting.

8. Membership

All old pupils of Bishopshalt School shall be eligible for membership. Past and present members of the staff and governors of Bishopshalt School shall be honorary members of the Association.

Partners of members may participate in Association activities by becoming Associate Members.
